Alumni Spotlight

What do you do now? How did you discover your current career interest?

In the deepest point of the darkest cave of the tallest mountain of a secluded uncharted island in the middle of the sea, I found my calling, my passion, my raison d'etre, my very reason for being: the job of private equity associate.

JK, obviously. There's a big rush to PE from banking, just like there's a big rush to banking from Stern, or to college from high school. The hope is that PE has more of what you like about banking and less of what you don't. And so far it's delivered by letting me deal more with business' strategic financial decisions and deal less with unreasonable personalities and long hours. Ultimately, though, the actual junior-level work of all of these jobs look and feel very similar.

How did you get involved with FS?

I think as a pre-frosh I was tipped off by my only Stern contact to keep an eye out for Finance Society – the club has always drawn a reputation for its colorful leaders and strong recruiting performance. As a result, I attended every general meeting workshop in my Freshman fall, which ended up being crucial in my e-comm interviews. This is why when I became an e-comm chair in my senior year we put such a strong emphasis on using the general meetings as study sessions for the interviews' technical questions. The rest is just history – I applied when the spring semester came around and was fortunate enough to get a spot. Subeg ('16) and Rushi ('17), my interviewers, also eventually became two great role models within the organization; my e-comm curriculum was based almost entirely around Subeg's.

What was the best part of being in FS? Any favorite memories?

We've always pitched FS as a club where you can find a great job and a great friend group. It's probably not surprising that the most enduring moments of the experience were all of the social events – every retreat (even the one in Bayonne), hiking, marshmallow throwing fights, apple picking, alumni mingles, parties, poker, etc. Probably more surprising and almost more meaningful were the small moments around school. The Class of 2020 playing Smash on some TV that's older than the freshmen, the Class of 2021 sitting in a circle drinking boba and bullying me for eating a family-sized tub of Wendy's chili.

What do you hope to accomplish in 5-10 years?

Who knows? Five years ago was an entirely different time. I hope I'm still in touch with everybody in 5-10 years.

Any advice to give to the younger people reading this?

For those who are pre-recruiting, the most important advice I can give you is that life is long. There are millions of paths you can take to success, and you're already in a great position. Even if you face setbacks there will be plenty of time to catch up or do something that you end up liking even more – so just do your homework and everything will end up aces. For those who are post-recruiting, my advice is that life is short. Try to go out and do something fun every day, or at least every weekend. And spend some money. I cannot tell you how many plans I shot down because I thought it'd be too expensive – I was paying for my own rent and still had several thousand at graduation. One day much, much sooner than you realize you'll have plenty of money and no time to use it. So go book the cheapest flight to Miami or something.

What do you do now? How did you discover your current career interest?

I am a student at Yale Law School. I had worked on a political campaign during college and was intrigued by the possibilities of a law career. I knew I wanted to pursue investment banking right after college for the work experience, skills, work ethic, and discipline, all of which I continue to find valuable, but I also considered what I would like to do after banking.

What are your career options?



What are your career interests?


